Peggy Berkeley called the meeting to order at 7:03 pm. No action was taken on the September 14, 2020 PTSO Board meeting minutes.

### Reports:

### Principal: Leigh Dunavant –

Principal Dunavant is waiting on all the responses for the intent. They will be making sure that the resources in school will match those who will be attending. Currently, Ms. Dunavant does not anticipate many staffing stages. There may be adjustments to classroom (physical space).

Many families still have not responded on the intent form. From what has been submitted, more people have opted for the virtual option over in person.

Athletics have started. Band will start in spring. They are still figuring out the details on all of the events. In response to a question, Ms. Dunavant reiterated that you will still be able to participate in sports or band even if you are on the virtual school option.

#### Treasurer: Robin Pfeffer -

Robin and Peggy met to work on budget. They were conservative on their assumptions of income in the Cave and Eagle Fund and their expected expenditures (standard operational budget and limited expenditures on normal activities; will hold scholarship value). Budget proposed is a \$9,160 deficit budget but with projections will still have \$8,054 in the bank.

Bryan will be sending out the Budget to the board for approval. Once approved it will be put on the Facebook page/ website for action by the membership.

The October 12, 2020 BB&T bank balance was \$18,988.94. Since the last report the Cave income was \$1,494.95 and Eagle fund/membership donations have been \$5,750.00. Expenses were for the Cave at \$1,848.52 (considered for budget purposes as a negative income), Paypal for \$204.05 and a purchase of \$78 for the website. The current bank balance, November 9, 2020, is \$24,103.82.

YTD income is \$7,245.45 and expenses are \$2,130.57.

## Membership/Eagle Fund: Cindi Houtz-

Eagle fund/ membership \$5,625.

Peggy suggested that we drop a periodic note here and there on Godwin Parent Facebook page.

### Cave: Kelly Shaffer-

Cave is still selling items. More hoodies were ordered and are available for sale.

Martha Shippee is still making deliveries

There were some discussions of setting up some sales for returning in person students.

Holly mentioned making a push for clothing near the holiday.

Ms. Dunavant said she can post something to the student Instagram page. There is also an Instagram page for the Cave that may be reactivated.

### Programs: Peggy Berkeley for Pam Gibbs-
